Fighter Medical Information

All required forms can be found on our website www.dca.ca.gov/csac.

Federal ID (boxing) or MMA ID \$20 – Requires the application, headshot, and a copy of a government issued ID

CA Professional Fighter License Application \$60 – Requires the following medical exams:

- **Physical** – Done by an M.D. or D.O.; valid for 12 months.
- **Eye** – Done by an ophthalmologist; valid for 12 months.
- **Neuro** – Done by a neurologist or neurosurgeon; valid for 12 months.
- **EKG and Cardio Summary** – Done by M.D. or D.O., CSAC summary form required; valid until age 40, unless requested by a physician.
- **MRI and MRI Summary** – Done by a neurologist or neurosurgeon, CSAC summary form required; valid for 3 years.
- **Labs** - HIV, Hep B Antibody, and Hep C Antigen; valid for 6 months.
