This citation details each violation charged and the order of correction where applicable. **It is the licensee's responsibility to read the entire citation.**



SECTION 89. Control and Reporting.

(a) Upon renewal, a licensee who is required, pursuant to Section 87, to obtain continuing education must provide a written statement, signed under penalty of perjury, certifying that the requisite number of continuing education hours has been obtained. The licensee shall disclose the following information concerning courses or programs claimed as qualifying continuing education:

- (1) Course title or description
- (2) Date of completion
- (3) Name of school, firm or organization providing the course or program
- (4) Method of study, i.e., whether course or program is self-study, live presentation or Group Internet-Based Program (Webcast)
- (5) Number of hours earned.

**Description
of Violation:**

For the license renewal period that ended June 30, 2011, Anvita Nandkeolyar failed to provide a written statement, signed under penalty of perjury, certifying that the requisite number of continuing education (CE) hours had been completed.

**Order of
Abatement:**

Comply with all CBA statutes and regulations.

**Order of
Correction:**

- Submit certificates of completion documenting a minimum of 80 hours of qualifying CE in the appropriate subject areas for the period that ended June 30, 2011. Hours completed cannot be used towards any subsequent license renewal.
- Pay the administrative fine as set forth in the citation.

SECTION 52. Response to Board Inquiry.

(a) A licensee shall respond to any inquiry by the Board or its appointed representatives within 30 days. The response shall include making available all files, working papers and other documents requested.

Ms. Nandkeolyar was mailed deficiency letters on January 14, 2012, March 15, 2012, and June 12, 2012. On June 20, 2012, Ms. Nandkeolyar stated via phone that she would submit the requested documentation. To date, Ms. Nandkeolyar has failed to respond.
