PRO-DEBUT FIGHTERS: All Pro-Debut fighters must be signed off by a licensed CA Pro-Trainer effective January 1, 2014 using the Pro-Debut Participant Form. Pro-Debut Participant forms must be completed by said Pro-Trainer. If you need a CA Pro-Trainer license application, please let me know. The Pro-Trainer application fee is \$200.00. Pro-Debut fighters are required to have a Boxing Federal ID or MMA National ID **PRIOR** to the event. Promoters are required to submit a Fight Fax for Pro-Debut boxers.

MEDICAL CUT-OFF TIMEFRAME: This packet will be sealed and shipped **THE DAY BEFORE WEIGH-INS at 2:00pm PST**. Any items indicated with **NEED**, at that time, must be submitted to the Lead Inspector at the weigh-in. **Physical Copies only. NO emails. NO faxes. NO exceptions.**
