The following procedures have been established for the submission of a **NEW** Boxer Federal Identification Card Application to the California State Athletic Commission (CSAC).

NOTE: ALL APPLICATIONS FOR A NEW BOXER FEDERAL IDENTIFICATION CARD SHALL BE SUBMITTED IN PERSON TO ONE OF THE FOLLOWING CALIFORNIA DEPARTMENT OF CONSUMER AFFAIRS LOCATIONS.

No less than forty eight (48) hours prior to scheduled Bout, the Applicant shall make an appointment to appear in person to one of the local California Department of Consumer Affairs Field Offices listed above in order to submit an application. The Applicant shall arrive promptly at the scheduled appointment time.

The Applicant shall provide following documents:

- A completed and signed Boxer Federal Identification Card application. If the applicant cannot obtain an application before the appointment, a blank Boxer Federal Identification Card application will be provided.
- A recent passport sized photograph. *Note: An electronic picture emailed to FederalID@dca.ca.gov is preferred. Please include Applicant's full legal name in subject line.*
- Two forms of governmental identification (social security card, passport, student ID, military ID, green card). Non U.S. citizens are required to provide a current passport. *Note: An electronic copy emailed to FederalID@dca.ca.gov is preferred. Please include Applicant's full legal name in subject line.*

Note: A \$20 Processing Fee is required before a Boxer Federal Identification Card will be issued. However, the processing fee will not be accepted at the Division of Investigation Field Offices listed above. Applicant must mail payment or submit payment in person to the CSAC headquarters along with a copy of the application.
