## NOTIFICATION OF PROPOSED EMERGENCY REGULATORY ACTION

## Subject: California State Athletic Commission's Resiliency Procedures

## **To All Interested Parties:**

On April 28, 2020, Governor Gavin Newsom announced a Resiliency Roadmap (Roadmap) that includes four phases for California's gradual reopening process. Phase III of this plan will allow sporting events to begin without live audiences. The attached regulation is written to allow the California State Athletic Commission (Commission) to hold combat events during Phase III of the Roadmap, and beyond.

Government Code section 11346.1 (a)(2) requires that, at least five (5) working days prior to submission of the proposed emergency action to the Office of Administrative Law (OAL), the adopting agency provide a notice of the proposed emergency action to every person who has filed a request for notice of regulatory action with the agency. After submission of the proposed emergency to OAL, OAL shall allow interested persons five (5) calendar days to submit comments on the proposed emergency regulations as set forth in Government Code section 11349.6.

Upon filing, OAL will have ten (10) calendar days within which to review and make a decision on the proposed emergency action. If approved, OAL will file the regulations with the Secretary of State, and the emergency regulations will become effective for one hundred and eighty (180) days. Within the 180-day effective period, the Commission will proceed with a regular rulemaking action, including a public comment period. The emergency regulations will remain in effect during this rulemaking action. Attached to this notice is the specific regulatory language of the Bureau's proposed emergency action and the Finding of Emergency.

The Commission plans to file the Emergency Rulemaking Package with OAL at least five (5) working days from the date of this notice. If you wish to comment on the Finding of Emergency or the proposed emergency regulation, both the Commission and OAL must receive comments within five (5) calendar days of the Commission's filing with OAL. During an emergency filing of proposed regulations, it is the Commission's discretion to respond to any public comment received in the five (5) day public comment period.
