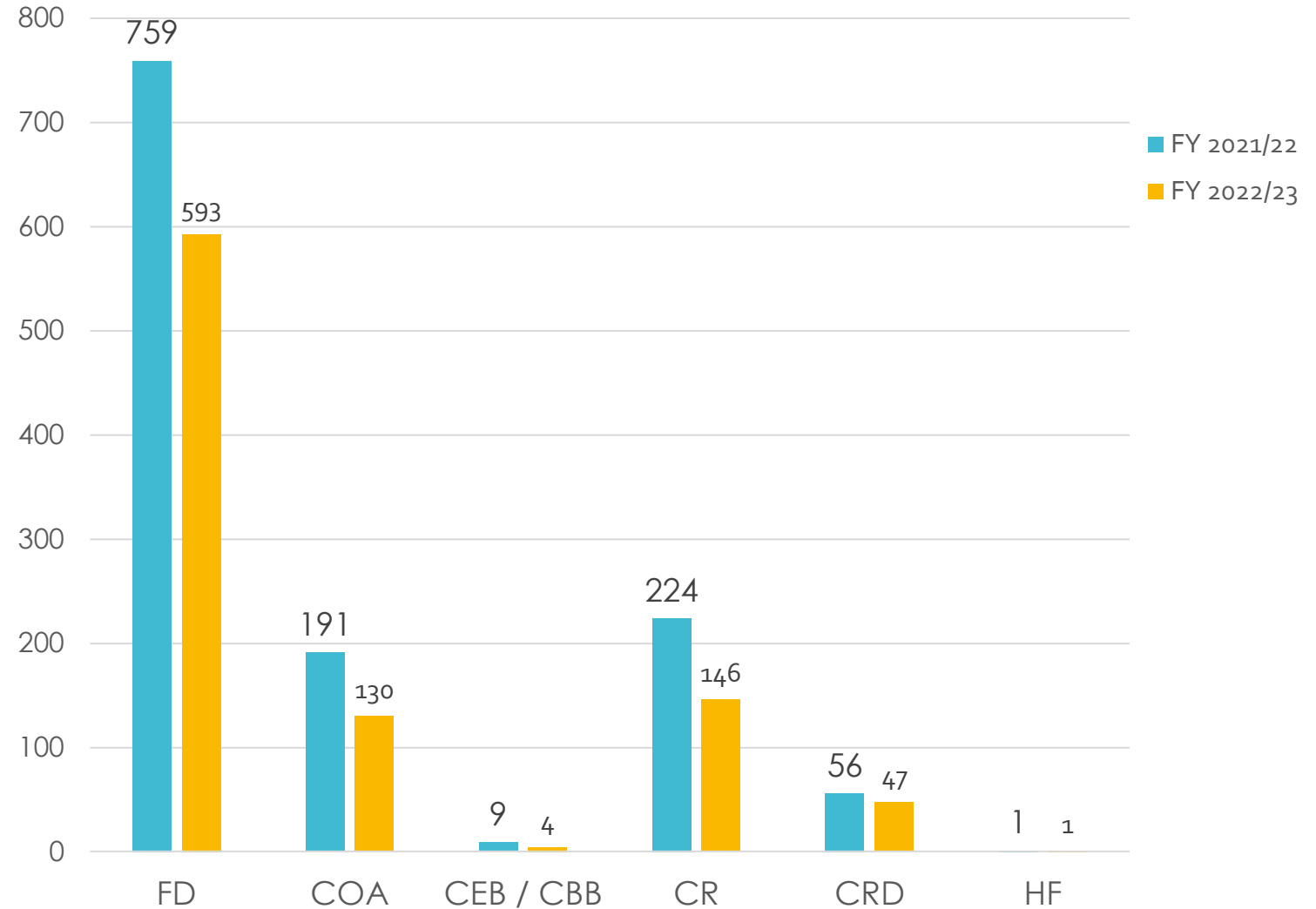

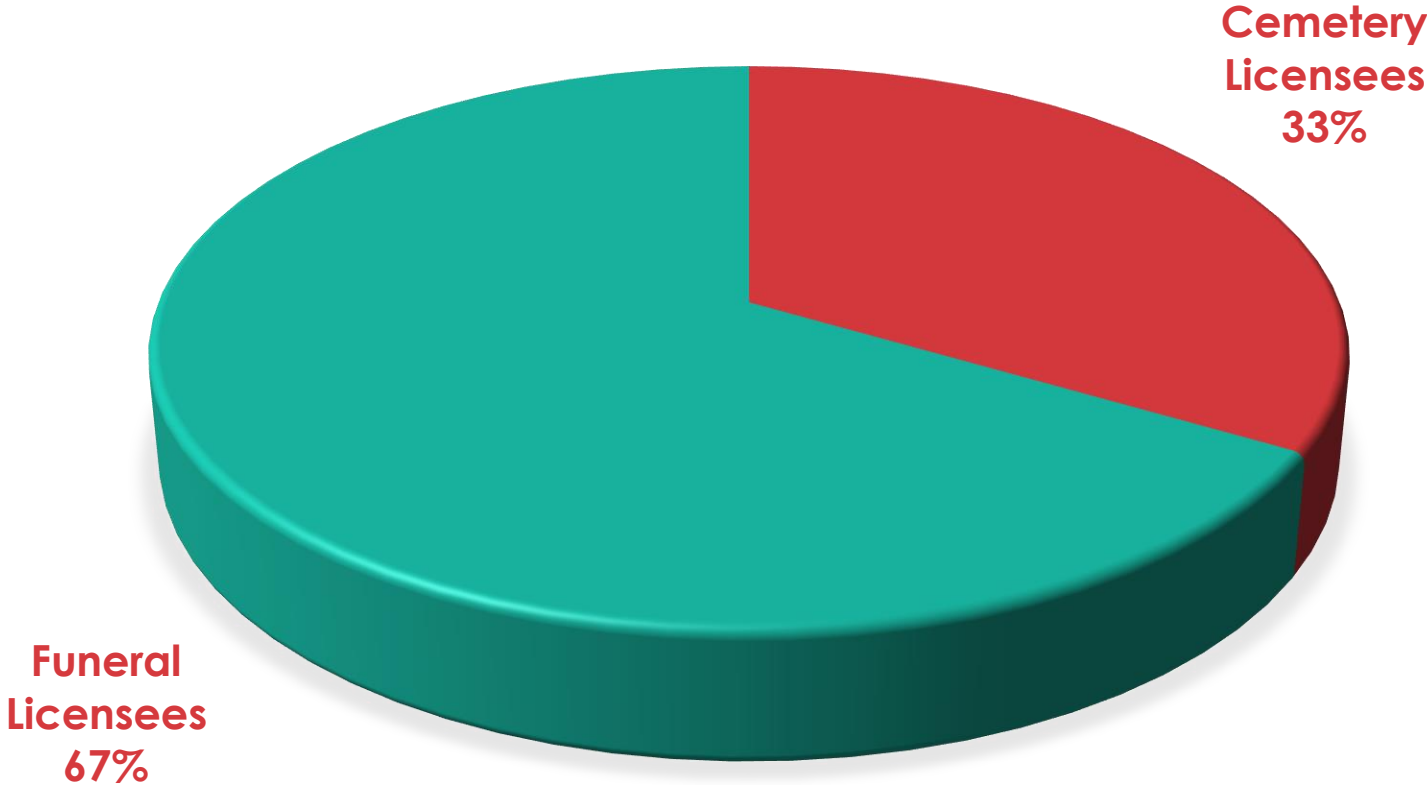
Inspections Completed



FY 2021/22 Total Inspections Completed = 1,240

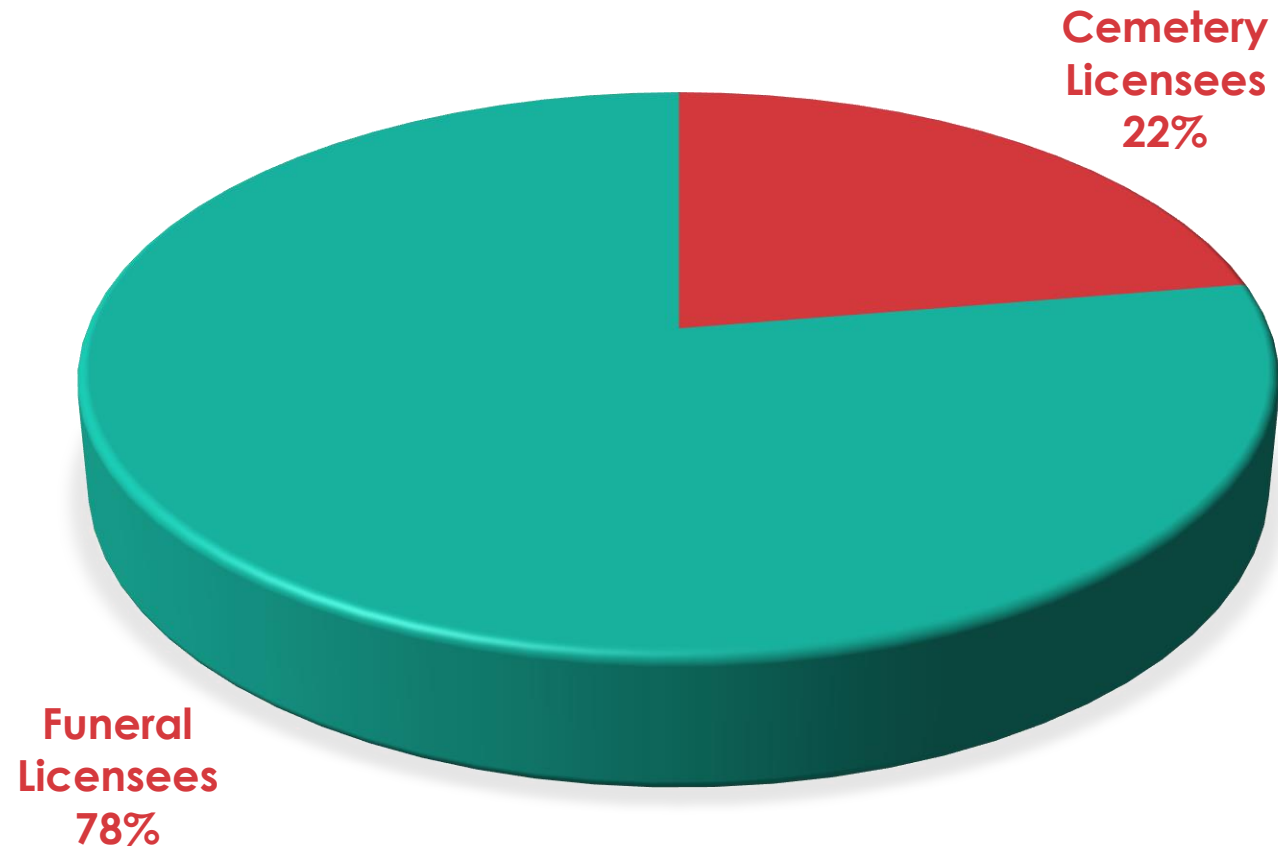
FY 2022/23 Total Inspections Completed = 921
