



CPA LICENSE APPLICATION CHECKLIST

Check the statement below that applies to you to determine what application license type materials must be submitted.

Application License Type

- A:** Passed the CPA Exam as a California candidate and has not been issued a valid license in any state.
- B:** Passed the CPA Exam as a candidate of a state other than California and has not been issued a valid license in any state.
- C:** Has been issued a valid license to practice public accounting in a state other than California.
- C (4/10):** Has been issued a valid license in a state other than California and has been active and in good standing for at least four of the last ten years.
- D:** Once held a license in California and CPA license was cancelled due to nonpayment of fees.
- E:** Passed the Canadian Chartered Accountant Uniform Certified Public Accountant Qualification Examination (CAQEX) or the International Uniform Certified Public Accountant Qualification Examination (IQEX).
- F:** California licensee originally issued to perform general accounting services who has completed the required experience to sign reports on attest engagements.

Application License Type A through E require the following:

U.S. Education – Official transcripts may be submitted with your CPA License application OR mailed directly to the CBA. All transcripts must be in an unopened envelope sealed by the school or the schools designated third party transcript provider.

Foreign Education – Applicants who attended or graduated from foreign schools must have their foreign transcripts evaluated by a CBA-approved foreign credentials evaluation service. Official evaluations may be submitted with your application or mailed directly to the CBA from the evaluation service. All foreign education evaluations MUST be in an unopened envelope sealed by the evaluation service. The PETH Examination is provided by the California CPA Education Foundation (CalCPA). CalCPA will notify the CBA when you have successfully passed the PETH Examination. Visit www.calcpa.org/ethics-exam for more information.

Once your application has been received by the CBA, you will receive an acknowledgement email including authorization and instructions to submit fingerprints for the purposes of conducting a criminal history record check with the California Department of Justice and the Federal Bureau of Investigation.
