



## **OPEN SESSION**

## Agenda Item 1 - Call to Order / Roll Call / Establishment of Quorum

The meeting was called to order at 10:00 a.m. by Chair Peter Villegas. Executive Officer (EO) Andy Foster called roll and a quorum was established.

## Agenda Item 2 – Chairman's Opening Remarks

Chair Villegas welcomed everyone to the meeting and introduced the new Commissioners, Ron Fiore, and Scott Wetch. Tara Welch joined the meeting in place of Legal Counsel Ken Swenson.

## <u>Agenda Item 3- Review and Possible Action to Approve March 6, 2023, Meeting Minutes</u>

EO Foster presented the March 6,2023, Commission meeting minutes for approval. Commissioner De Mars summitted some changes, those changes were added to the record.

Commissioner Gruwell moved to approve the meeting minutes.

Commissioner D. De Mars seconded the motion.

No Commission or public comments

The motion passed 4-0 by roll call vote with 3 abstain.

## <u>Agenda Item 4- Discussion and Possible Action Re: Specialty License Plate</u> <u>Selection for Funding of the Boxers Pension Plan and Other MMA Pension Plans</u>

EO Foster presented the selection of specialty license plates created by the DCA design office for the Commission to review. EO Foster informed that Commission that they would need to choose a design before the Commission could move onto the next steps in the process. The Commissioners reviewed the presented designs options and the application process.

#### **Commission Comments**

Commissioner Wetch stated that he had worked on several specialty license plate applications and offered help the Commission staff as they move forward in the process.

Commissioner Hendrickson also offered to help the Commission staff with the specialty license plate application.

Chair Villegas asked if Commissioner Wetch and Hendrickson would be willing to serve on a Specialty License Plate Subcommittee, both Commissioners stated they would.

#### **No Further Commissions Comments**

The Agenda Item was tabled for a future Commission meeting.

## Agenda Item 5- Discussion and Possible Action Re: the Reinstating of the Delegation of Amateur Kickboxing to IKF Kickboxing Muay Thai Federation

EO Foster informed the Commission that since the March 6, 2023, Commission meeting, the Commission has been regulating all amateur Kickboxing and Muay Thai throughout the state due to International Kickboxing Federation (IKF) voluntarily withdrawing its delegation due to paperwork issues. EO Foster informed the Commission that the IKF had gotten their delegation paperwork in order and was now requesting delegation approval. IKF representative, Toni Fossum was present at the meeting.

EO Foster added if IKF's delegation was reinstated that the Commission would continue regulate Professional/Amateur Kickboxing and Muay Thai events.

Commissioner Gruwell **moved** to reinstate IKF Kickboxing Muay Thai Federation delegation for amateur Kickboxing and Muay Thai events for a six-month temporary period beginning June 12, 2023. At the end of the six-month period the IKF Kickboxing Muay Thai Federation California would need to come before the Commission for review to determine if their delegation would be renewed.

Commissioner Hendrickson seconded the motion.

No Commission or public comments

The motion passed 7-0 by roll call vote.

## <u>Agenda Item 6 – Discussion and Possible Action Re: Thompson Boxing Promotions</u> <u>Request to Hold an Event using Team Combat League Rules</u>

EO Foster presented the proposed Team Combat League event request submitted by Thompson Boxing and explained the rule set that Team Combat League uses. EO Foster explained that Team Combat League uses boxing rules, but the final Team Combat League score would be based on a point system which would be used to determine the teams score at the end of the night. EO Foster stated that Thompson Boxing and Team Combat League are requesting approval to hold the finals in California. EO Foster informed the Commission that he sees no issues with Team Combat League and would recommend the Commission to approve the proposed event request with the option for him to approve up to two additional Team Combat League events.

Commissioner Dr. De Mars **moved** to approve the Thompson Boxing Promotions request to hold an event using Team Combat League Rules and to allow the Executive Officer the option to approve Thompson Boxing Promotions to hold two additional events using Team Combat League Rules.

Promoter, Roy Engelbrecht informed the Commission that Thompson Boxing had also reached out to The Hanger in Costa Mesa as a possible venue.

## <u>Agenda Item 7 – Introduction of the SOLID Strategic Planning Team to Discuss the</u> 2024-2028 Strategic Plan

EO Foster introduced Elizabeth Coronel and Ann Fisher from the SOLID Strategic Planning Team. The SOLID Strategic Planning Team presented and introduced the strategic planning process to the Commissioners for the creating the new 2024-2028 Strategic Plan for the Commission

## <u>Agenda Item 8 – Review and Discussion Re: the Request for Delegation of Amateur Kickboxing to the World Association of Kickboxing Organizations (WAKO)</u>

EO Foster stated that at the March 6, 2023, Commission meeting the Commission passed a motion requesting that the World Association of Kickboxing Organizations (WAKO) submit a written request with supporting documentation to the Commission for review and that they were to appear before the Commission at the June 5, 2023, meeting. EO Foster stated that WAKO had submitted their delegation application paperwork to legal for review and it was in order. Rob Zbilski, President of WAKO USA Kickboxing, was present at the meeting.

Chair Villegas advised that Mr. Zbilski continue to work with EO Foster regarding WAKO's request for delegation.

## Agenda Item 9 - Executive Officer's Report

a. Budget update for the support fund, the neurological fund, and the pension program

EO Foster stated that the Commission had deposited \$2.3 million in the support fund, \$30K in the neuro fund, and \$97K in the pension fund. EO Foster added that the Commission will exceed revenue projections by the end of the fiscal year.

EO Foster introduced Cyril Shah with Raymond James, he provided the year end pension report which was included in the meeting materials. Mr. Shah stated that the pension investment account was healthy with a balance of \$4.613 million. Mr. Shah added that \$300 thousand has been moved from the investment account to the distribution account each year. Mr. Shah added that even with the withdrawals from the investment account the value of the investment account has stayed relatively flat, which is something the Commission should be proud of.

EO Foster introduced Matt Harrington with Benefit Resources the administrator of Boxers Pension Plan. Mr. Harrington informed the Commission that he was available to answer any questions that the Commission may have.

Commissioner De Mars asked Mr. Harrington to explain the forfeiture account. He stated that the money in the forfeiture account are the funds from a boxer's pension that weren't requested timely but that those funds could still be paid out to the boxer if he or she came forward requesting distribution.

Commissioner De Mars asked if the Commission had the Boxers Pension information available in English and Spanish, EO Foster stated the Commission has the information available in both languages.

Commissioner Wetch asked Mr. Harrington what goes into the evaluation of a distribution request made by a boxer who has funds in the forfeiture account. Mr. Harrington stated that the evaluation is completed by the Commission staff once they receive the request for distribution. The request for distribution is then sent by the Commission to Benefit Resources.

Chair Villegas asked for information regarding payments made to beneficiaries if the boxer has passed away. Mr. Harrington stated that beneficiaries can come forward to request distribution but added that the Commission would need to request documentation to prove the individual was a beneficiary of the boxer.

## b. Report on the pending and proposed regulations

EO Foster stated that the Commission has a new regulatory counsel, Steven Wong. Mr. Wong stated he was new to the Department and has been working Commission staff on reviewing the two proposed regulatory packages.

## c. Status update of delegated entities

## California Amateur Mixed Martial Arts Organization (CAMO)

JT Steele, President of CAMO, submitted his written report to the Commission, which is contained in the meeting materials. Mr. Steele informed the Commission that the CAMO summer schedule is busy. He added that CAMO held a Promoter summit in Visalia which was well received by all who attended, he stated that holding a Promoter summit will likely become a yearly meeting. Mr. Steele informed the Commission that lead Inspector and Referee, Ryan Spinks passed away tragically in a car accident while he was traveling home from a USFL event. Chair Villegas expressed the Commissions condolences to Mr. Spinks' family and friends.

#### USA Boxing

Mr. Mike McAtee, Executive Director of USA Boxing, submitted his written report to the Commission which is contained in the meeting materials.

## United States Fight League (USFL)

Jon Frank of the USFL submitted his written report to the Commission, which is contained in the meeting materials. Mr. Frank echoed what Mr. Steele stated about Mr. Spinks and added that he will truly be missed by the USFL family.

#### d. Staffing Update

EO Foster stated that the Commission is still operating very lean with 3 vacancies. EO Foster added that the Commission is going to try and fill one of the vacancies next fiscal year.

## e. Upcoming Event Schedule

EO Foster informed the Commission that the Jaime Munguia was competing on June 10<sup>th</sup> in Ontario for the vacant WBC Siler Super Middle title. EO Foster stated that 360 Promotions has a UFC Fight Pass event scheduled for July 22<sup>nd</sup> at Commerce Casino. He added that Westside Boxing Promotions is trying to bring boxing back to the Bay Area and that they had an event scheduled for June 24<sup>th</sup> at the Cow Palace.

## Agenda Item 10 - Public Comments not on the Agenda

Promoter, Roy Engelbrecht stated that as the oldest licensed Promoter in California and one who attends at least 90 percent of Commission meetings, that prior to EO Foster the Commission gave very little in way of a report regarding the Boxers Pension Plan. Mr. Englebrecht added that since the appointment of EO Foster, the Commission has been giving reports about the pension plan at Commission meetings, trying to reach Boxers who are owed a Pension and has been giving out information to Boxers about the Pension plan.

Cameron Frizzell updated the Commission on his progress on training to become a professional boxing referee.

## **BACKGROUND**

On July 23, 2023, the Commission received a petition to change a decision from JC Danna on behalf of Joseph Keith. The bout occurred at the Hard Rock Casino in Wheatland on July 22, 2023. The bout ended by referee stoppage from strikes at 2:57 of round 1.

At 3:07 of round 1, fighter Sczar Charles takes down Joseph Keith and goes into side control. Mr. Keith works his way out of the bottom position to get Mr. Charles into his open guard. At 2:36, Mr. Charles stands up and begins to throw punches and elbows to Mr. Keith while he is on his back against the cage. At 2:25 both fighters stand up with Mr. Charles trying to get Mr. Keith in a guillotine choke. The fighters go the canvas with Mr. Charles landing on his back. Mr. Charles is able to make his way to his feet while holding onto the left elbow of Mr. Keith. Mr. Charles turns his body towards Mr. Keith, wrapping his left hand around the back of Mr. Keith's head while holding onto his right arm while Mr. Keith is grounded (right knee up, left knee down). At 2:19 Mr. Charles moves his body slightly away from Mr. Keith's and lifts his left knee. At the time that the knee is coming forward, Mr. Keith extends his left arm to try and stop the knee. After the knee makes contact with Mr. Keith, Mr. Charles steps back and throws a right hand to Mr. Keith's head. At 2:17, Mr. Keith plants both his hands onto the canvas while Mr. Charles continues to throw strikes at Mr. Keith. Mr. Keith then begins to turn away and cover while Mr. Charles moves around behind Mr. Keith. Mr. Keith then goes into a "turtle position" while protecting his head from the strikes Mr. Charles is throwing from a standing position. At 2:06, Mr. Keith stands up with his face toward the cage while Mr. Charles continues to throw strikes. Mr. Charles turns Mr. Keith and begins throw more strike which are unanswered and at 2:00 Mr. Charles throws a right knee which hits Mr. Keith in the face. With 1:57 left in round 1, Referee Ed Collantes stops the bout due to strikes.

## APPEAL DETAIL SUMMARY

Mr. Danna, on behalf of Mr. Keith, alleges that during the first round, Mr. Keith received an illegal knee to the head while he was grounded as well as multiple punches to the back of the head. Mr. Danna claims the illegal knee caused Mr. Keith to become dazed and he was not able to recover.

## **ADDITIONAL INFORMATION**

Attached for your review is a written statement from Referee Ed Collantes, written statements from the Association of Boxing Commissions and Combative Sports (ABC) Fighters Committee and a video of the bout.

## **EO RECOMMENDATION**

I believe that the Commission referee assigned to this bout made the correct call. While I do believe that a minor foul occurred, the contact is incidental and did not significantly contribute to the fight stoppage. I recommend the decision of Referee Collantes stand.

#### **Unified Rules of Mixed Marital Arts-Fouls**

12. \*Kneeing and/or Kicking the head of a grounded opponent: A grounded fighter is defined as: Any part of the body, other sole of the feet touching the fighting area floor. To be grounded, the palm of one hand (a flat palm) must be down, and/or any other body part must be touching the fighting area floor. A single knee, arm, (not fingers) makes the fighter grounded without having to have any other body part in touch with the fighting area floor. At this time, kicks or knees to the head will not be allowed.

#### **California Code of Regulations Article 8**

#### § 368. Change of Decision.

- (a) A decision rendered at the termination of any boxing contest is final and shall not be changed unless following the rendition of a decision the commission determines that any one of the following occurred:
- (1) There was collusion affecting the result of any contest.
- (2) The compilation of the scorecard of the judges, and the referee when used as a judge, shows an error which would mean that the decision was given to the wrong boxer.
- (3) There was a violation of the laws or rules and regulations governing boxing which affected the result of any contest.
- (4) The winner of a bout tested positive immediately after the bout for a substance listed in Rule 303(c).
- (b) A petition to change a decision shall be in writing and fled by a boxer or the boxer's manager within five (5) calendar days from the date the decision was rendered.
- (c) If a petition to change a decision is not fled in writing within five (5) days of the decision, the commission may, upon the vote of at least a majority of the commissioners present, hold a hearing to change the decision at any time.
- (d) If the commission determines that any of the above occurred with regards to any contest then the decision rendered shall be changed as the commission may direct.

Re: Referee Statement - Petition - Keith vs Charles

I have reviewed the written petition and the submitted videos. I recall the exact situation as it transpired. I have submitted a video in slow motion to support my visual conclusion.

Here is my statement regarding the knee to the head of a grounded opponent:

- My position was excellent to view the action at the time the knee landed on the fighter.
- The fighter did have his knee down at the time of impact and thus was a grounded opponent.
- I did consider this blow to be a legal strike for the following reasons:
  - The knee landed in the center of his chest. When viewing my video, please pay close attention to:
    - The fighter's left side of his rib cage. You will notice that it moves simultaneously when the knee lands on the chest.
    - The fighter's right knee moves forward after impact as his upper body is moving backwards after the knee lands, which is consistent when a knee lands on the chest.
  - The face was pulled onto the thigh but in my opinion this impact was minimal, not substantial, as the force of the knee was dissipated on the fighter's chest.
  - As a 12 year pro, I have learned to rely on post blow evidence to support what I saw in these fast developing situations. The evidence confirmed that a concussive illegal knee did not land on the head as:
    - The fighter did not collapse due to the brain trauma such a concussive blow would have created.
    - The fighter, post blow, kept his eyes on his opponent and protected himself by lifting his hand and ducking when a subsequent blow was thrown at him. A concussed fighter would not be able to do this.

Here is my statement regarding the blows to the back of the head at the end of the fight:

- The question for me is targeting the back of the head. I don't believe that the back of the head was targeted as the fighter was throwing hooks thus targeting the ears, which is a legal target area.
- In a fight ending sequence with a lot of movement, at times, the downed fighter could cause a blow to land to the back of their head by their movement to escape.

The fight ending sequence had started and the damage to the fighter was due to multiple legal strikes before the knee situation and continued afterwards until I determined that the fighter was receiving unnecessary damage and was overwhelmed, prompting me to stop the fight.

## Statements from the Association of Boxing Commissions and Combative Sports (ABC) Fighter Committee

**Erik Magraken**: "I'm not a fighter but as a lawyer I would argue that an incidental thigh graze to the head is not a knee or a 'kick.' There is no kicking technique in MMA where you are taught to target your opponent with your thigh."


**Anthony Cummings (Colorado Commission)**: "Based on review, seems to be incidental and it appears that only the thigh makes contact, not actually the knee."

**Carlos Newton**: "I agree with the outcome based on: The Commission ruled that while there may have been some illegal contact it was incidental it did not meaningfully contribute to the stoppage."

**Sarah Kaufman**: "I agree with the other contributors and the Commission review; if the thigh did make contact to the head, it was incidental and did not contribute to the fight stoppage. The impact was observed at the end of the bent limb (the knee) which was thrust in a horizontal plane at the chest compared to an arcing vertical plane toward the face. The offensive fighter appeared to have control over his limbs at the time of impact. As such the appeal should be denied and the bout result should stand."

Jack Reiss: "As a combative sports official, my two cents worth is no harm, no foul."

**Din Thomas:** "That dude is tripping. He's looking to get a loss erased. If a thigh to the face causes you not to continue, you don't deserve to win."



## A. Budget Update for the Support Fund, the Neurological Fund, and Pension program

As of September 1, 2023, the Commission has deposited \$132,183.50 to the support fund, \$3,864.28 to the neurological fund, and \$8,318.95 to the Boxer Pension Fund.

According to the Raymond James statement, the Pension Investment account has approximately \$4.604 million dollars as of July 31, 2023.

The Commissions event schedule is the lightest I have seen since the COVID Pandemic, and this could impact the Commission reaching the projected revenue for this fiscal year. The merger of Showtime and Paramount plus is impacting the scheduling of TGB Promotions (Premier Boxing Champions) boxing events and Bellator MMA events.

## B. Report on Pending and Proposed Regulations

- 1. Pension Plan (Amendment to Title 4, California Code of Regulations sections 401- 408.) This proposed language to remove the Break In Service requirement and to clarify how the Commission calculates the pension assessment as it relates to complimentary tickets issues versus redeemed. Additional work is needed on the proposed language before this is brought to the Commission for a vote.
- **2. Dehydration and Rehydration** (Amendment to Title 4, California Code of Regulations section 299.) The Commission approved the proposed language of this section at the last meeting on March 6,2023. Commission staff is updating the Initial Statement of Reasons to send to the DCA Regulations Unit.

## C. Update from the 35<sup>th</sup> Annual Association of Boxing Commissions and Combative Sports (ABC) Conference that was held in Las Vegas, NV.

As chair of the ABC Mixed Martials Art Rules and Regulations Committee, I brought forward 2 proposed procedural changes at the Conference which passed.

- **1.** Utilizing a Cutperson after a foul but during a round:
  - When a Fighter is the recipient of either an accidental or intentional foul and receives a laceration from the illegal action, the Referee in charge after calling time and putting the fighters into neutral corners MAY call upon the cutperson assigned (or in regional shows a corner with no coaching permitted) to the injured fighters corner to enter the cage during the 5-minute break and administer aid to the cut to help stop the bleeding. Then when cleared by the Ringside Physician the fighter can return to the action, with no more than the 5-minute time elapsed. The cutperson may only work on the cut or cuts associated with that particular foul.
- 2. Standing up fighters from the downed position and/or breaking fighters while they are standing and pinned against the cage.
  - The Referee shall either stand up or break the fighters when neither fighter is able to or fails to demonstrate real, significant and/or sustained effort to advance towards finishing the fight by any method. Simply maintaining what may be perceived as a superior position will not be considered effort to advance towards finishing the fight nor grounds for a guaranteed opportunity to maintain that position.

As chair of the ABC Medical Committee, I brought forward a proposed procedural change relating to how eye pokes are evaluated by the Referee and Ringside Physician which also passed.

- **1.** Referee Procedure for Eye Poke Evaluation:
  - Once the Referee calls time and the fighters 5-minutes for recovery has started, the Referee will allow the fighter 1 to 1 ½ minutes to recover from the eye poke. During this time the fighter is permitted the use of a cold compress or wet towel on the injured eye.
  - After the fighter has used their 1 to 1 ½ minutes to recover, the Ringside Physician will the evaluate the injured eye. If at all possible, the Ringside Physician will try and not shine any light into the injured eye as this can cause the eye to spasm. The Ringside Physician shall refrain from asking the fighter if they can see.
  - The Referee and Ringside Physician are to allow the fighter time to compose themselves so the fighter can then give a verbal "yes" or "no" that they can see.

Additionally, at the Conference I was appointed Chair of the ABC Boxing Officials Training Committee.





### III. Membership Information

#### **Standard Memberships**

There are two categories of memberships, athlete, and non-athlete. Both allow boxers, coaches, and officials to train, spar, and compete at sanctioned USA Boxing events. Membership fees are calculated by LBC. USA Boxing collects a standard amount of \$55.00 – \$75.00, per athlete membership and \$75.00 for each non-athlete membership (amounts vary by location). The remainder is voted on by the LBC's Board of Directors to assist them with administrative and operational expenses. In all, since the IKF was delegated to oversee Amateur Kickboxing and Muay Thai in California on March 17th, 2014 by the California State Athletic Commission, the IKF has sanctioned 356 events / regulated a total of 363 Amateur Kickboxing and or Muay Thai events as of August 31st, 2023.

#### **Highlights of IKF 3rd Quarter**:

- The IKF is continuing the training and education of our officials. Because of these trainings, there is increased communication between officials and coaches which has lead to fewer disputes about judging and has improved understanding about stopping fights to protect fighters.
- Our ongoing trainings include educating Ringside Physicians, which has lead to more uniformity as to when bouts should be stopped, and continued standardization of medical suspensions to follow those of CSAC.
- Our staff has been complimented by promoters and trainers for the extra effort put in to validating fight records, and issuing and enforcing suspensions.
- -Our new IKF Fight Platform has taken off with thousands of fighters already registered. This digital platform is easing the burden of matchmakers, cutting down on non-essential paperwork for representatives, and making it easier for commissions to find and confirm records and suspensions across the country. It is FREE for fighters to create their profile, and fans love it because fight results are updated in real time!
- At the beginning of August, 7 of our top notch California IKF Officials traveled to Atlanta, Georgia to work the Steve Fossum Memorial IKF World Classic. This 3 day event hosted over 150 amateur bouts with fighters from 5 different countries.

#### **Gender Breakdown of Fighters**

- On average 16.5% of our fighters in the state of California are female.
- On September 27th at the Commerce Casino in Commerce, CA, Big Troy Productions will be promoting a predominantly female Muay Thai card. 

#### **About the California State Athletic Commission**

The California State Athletic Commission (Commission) is responsible for protecting the health and safety of its licensees: boxers, kickboxers, and other martial arts athletes. Concerned with athlete injuries and death, the public established the Commission by initiative in 1924. The Commission is responsible for implementation and enforcement of the Federal Muhammad Ali Boxing Reform Act (Federal Boxing Act) and the California Boxing Act or State Athletic Commission Act (State Act). The Commission has four main functions: licensing, enforcement, regulating events and administering the Professional Boxers' Pension Fund (Pension Plan).

Specifically, the Commission establishes requirements for licensure, issues and renews licenses, approves and regulates events, assigns ringside officials, investigates complaints received, and enforces applicable laws by issuing fines and suspending or revoking licenses.

The Commission is one of 38 boards, bureaus, committees, and other programs at the Department of Consumer Affairs (DCA).

The Commission is comprised of seven members. Five members are appointed by the Governor and subject to confirmation by the Senate Committee on Rules. One member is appointed by the Senate Committee on Rules and one member is appointed by the Speaker of the Assembly. Commissioners are part-time employees who receive a \$100-a-day per diem. While there are no qualifications for an individual appointed to the Commission, no person currently licensed as a promoter, manager or judge may serve on the Commission. The law also specifies that efforts should be made to ensure at least four members have experience in either medicine as a licensed physician or surgeon specializing in neurology, neurosurgery, head trauma or sports medicine, financial management, public safety, and the sports regulated by the Commission.

The Commission Executive Officer (EO) is appointed by the Commission, subject to approval by the Director of DCA. The current EO has served since November 2012.

#### **How Does the Commission Accomplish its Mission?**

The Commission provides direction, management, and control for professional and amateur boxing, professional and amateur kickboxing, and all forms and combinations of full contact martial arts contests, including mixed martial arts (MMA) and matches or exhibitions conducted, held or given in California.

The Commission meets about six times per year to:

- Handle matters related to licensure and appeals of license denials, suspensions and fines.
- Propose and review regulations or legislation focused on maintaining the health and safety of fighters.
- Consider issues related to the Boxer's Pension Program and the Neurological Examination Account.
- Evaluate funding and revenue strategies.
- Address a variety of topics brought forth by stakeholders.

# 2015-2018 Strategic Plan Accomplishments

The Commission accomplished the following goals since the adoption of the previous 2015-2018 strategic plan.

- 1. In 2015, the California State Athletic Commission officially established the practice of dehydration and weight cutting as one of the largest industry wide health concerns. A summit was held in California on June 7, 2018, and the most pertinent issues were addressed first. Nearly 3 years later, after policies and regulations were implemented in the sport of mixed martial arts, the commission is expanding its efforts and successful protocol into the sport of boxing.
- 2. Legislation was chaptered that allows the Commission to fund special neurological examinations and explore new diagnostic imaging and testing to be used in relation to the examinations required by this section. The Commission obtained a contract with C3 Logix to provide the necessary tools to conduct neurological testing of athletes. This testing determines the relationship between the biomechanics of impact forces to the brain and their behavioral and physiological sequences to advance diagnostics, athlete care, return to play standards, understanding of the acute and long-term effects on brain health, and effective rehabilitation techniques to allow a safer environment for competition. The results of these tests are used to assist the Commission in making policy decisions regarding the health and safety of the athletes. The neurological testing is given before and after competition. This is a mission critical function that promotes the health, safety and welfare of participants in regulated combat sporting events.
- 3. The Commission promulgated the following regulations:
  - Pension Sections 401 406. The Commission identified three main problems with the administration of certain pension program regulations. First, the Plan regulations related to Lost Beneficiary / Forfeitures, section 405 (d), were not followed by the third-party administrator. The third-party administrator stated the 405 (d) regulation language was not followed because its intent was not clear. Secondly, the Commission identified some of the problems created by the third-party administrator not following 405 (d). Finally, the commission identified a funding source deficiency in the original language related to the Lost Beneficiary/ Forfeiture provisions. The changes in this regulation package addressed these problems.
  - Definitions, Prohibited Substances and Methods, Therapeutic Use Exemptions, Transgender Athletes – Sections 201.5, 303, 424-426 and 830-837. This regulation change mainly addressed the issues of prohibited substances and Transgender athletes. The Commission amended its regulations to adopt very strict bans on prohibited substances and methods; adopt a new regulation identifying the circumstances under which an athlete,

when medically necessary, may receive approval to use a prohibited substance or method; adopt a regulation setting out the rules governing Transgender athletes who apply to compete in Commission-regulated events. This rulemaking also made a technical clean-up amendment to one of its definitions, necessitated by the proposed adoption of "Transgender Athletes" regulations.

- Headgear Section 610. This regulation change required the use of headgear in amateur contests for the protection of amateur boxers.
- Dehydration & Rehydration Sections 297, 299 and 300. This regulation change was necessary to have an immediate effect in providing a safer weigh-in procedure as well as testing of athletes for severe dehydration prior to a bout. It helps prevent athletes from using severe dehydration as a method to make the contracted bout weight. The regulation change allows the CSAC appointed ringside physicians to test athletes for dehydration and to remove a contestant from a fight if the athlete is deemed to be severely dehydrated. Also, the regulation change prohibits the use of intravenous therapies to regain hydration after a weigh-in.
- Payment of Contestants Section 232. This regulation change mainly addressed that Athletes are not provided a minimum purse for fighting. This has allowed some promoters to exploit athletes by paying them \$1.00 instead of an industry minimum. This regulation set a minimum purse amount of one hundred dollars (\$100) per round.

California is the premier model for the safety and fairness of regulated combat sporting events.

- 1.1 Educate licensees with regards to the health and safety rules (e.g. weight cutting, hydration, using performance enhancing drugs) to keep licensees safe.
- 1.2 Enhance drug testing practices to reduce doping violations and protect licensees.
- 1.3 Research and analyze the data on concussion management protocol to further enhance and improve health and safety of fighters and contribute to global awareness.
- 1.4 Educate fight matchmakers on making the right matches in the appropriate weight class to strengthen matchmaking skills.
- 1.5 Increase resources needed to adequately address health and safety concerns.
- 1.6 Advocate for more uniform testing globally to protect athletes.
- 1.7 Reach out to Native American tribes and international stakeholders to strengthen relationships and be invited to assist with regulatory enhancements to the health and safety of fighters worldwide.

# **Goal 2: Licensing**

The Commission is an international leader in promoting licensing standards for participants in regulated combat sporting events.

2.1 Acquire a licensing database with online capabilities to be more efficient and save resources.

## **Goal 3: Enforcement**

The Commission protects consumers by preventing violations and effectively enforcing laws and regulations when violations occur.

- 3.1 Increase resources to identify unlicensed activity to the protect the public.
- 3.2 Develop training and evaluations for inspectors, referees, and judges to improve fights and preserve a sense of fairness.
- 3.3 Expand California State Athletic Commission's online presence to promote and educate about the Commission worldwide.

# Goal 4: Legislation, Regulation and Policy

The Commission pursues statutes, regulations, policies and procedures that strengthen and support their mandate and mission.

- 4.1 Identify needed legislation or regulation to anticipate challenges and increase revenues and efficiency.
- 4.2 Improve communication with DCA to keep abreast on the status of regulations.
- 4.3 Recommend proposed legislation that seeks necessary fee increases to keep up with costs and increase resources.
- 4.4 Streamline the process of approving regulations to allow for quicker implementation of regulations.

# **Goal 5: Organizational Effectiveness**

The Commission builds an excellent organization through proper governance, effective leadership and responsible management.

- 1.1 Create a succession plan to keep institutional knowledge and functionality of the Commission.
- 1.2 Work with DCA to separate duties and the pay scale for the lead athletic inspector versus athletic inspector positions to enhance recruitment, retention, and accountability.
- 1.3 Research online training options for inspectors to increase efficiency
- 1.4 Provide training to staff on public relations and building relationships to increase efficiency.
- 1.5 Formally acknowledge that obtaining a license does not create entitlement to assignments.

# Goal 6: Pension Plan

The Commission effectively manages the California Professional Boxers Pension Plan.

- 6.1 Explore broadening the Pension Plan to include Mixed Martial Arts athletes to fill a perceived need and protect and service our stakeholders.
- 6.2 Explore options to increase outreach to fighters who are entitled to receive the pension.
- 6.3 Obtain bids to contract out a private investigator on locating eligible boxers to pay pensions out to entitled fighters.

### **Goal 7: Outreach**

The Commission proactively communicates its mission, vision and goals to stakeholders.

- 7.1. Investigate mandatory meeting requirements for specific licensees to further educate licensees and build relationships.
- 7.2. Promote the benefits of participating in combat sports to the public to address damaging perceptions.
- 7.3 Allow the Executive Officer to attend more industry events to market the commission, increase exposure, and keep informed on the industry.
- 7.4 Allow staff to attend industry events to promote the commission, remain informed, and build relationships.

#### **Strategic Planning Methodology**

To understand the environment in which the Commission operates and identify factors that could impact the Commission's success, the California Department of Consumer Affairs' SOLID unit conducted an environmental scan of the internal and external environments by collecting information through the following methods:

- An online survey sent to stakeholders comprised of professionals, retired professionals, professional associations, promoters, media representatives and others who expressed interest in the strategic direction of the Commission.
   The online survey received 89 responses.
- One-on-one interviews with Commissioners, Executive Officer, and Assistant Executive Officer in July and August 2018.
- Focus group discussions with Commission staff in July 2018.

The most significant themes and trends identified from the environmental scan were discussed by the Commission during a strategic planning session facilitated by SOLID on October 2, 2018. This information guided the Commission in the development of the strategic goals and objectives outlined in this 2018 – 2023 strategic plan.
