Department Overview

DIVISIONS, BUREAUS, AND PROGRAMS UNDER THE DIRECTOR'S AUTHORITY – Includes the Bureaus of Automotive Repair and Smog Check, Electronic and Appliance Repair, Home Furnishings and Thermal Insulation, Security and Investigative Services, and Private Postsecondary and Vocational Education; Barbering and Cosmetology, Cemetery and Funeral, Arbitration Review, and Nursing Home Administrator Programs; the Divisions of Investigation, Consumer Information and Analysis, Licensing, Enforcement, Communications and Education, and Administrative and Information Services; and the Offices of Examination Resources, Executive, Internal Audits, Legal Affairs, and Legislative and Regulatory Review.

No. of Board Members are members of the Bureau of Security and Investigative Services' Disciplinary Review Committee, Bureau for Private Postsecondary and Vocational Education's Advisory Committee, the Barbering and Cosmetology Program Disciplinary Review Committee, and the Bureau of Automotive Repair Inspection and Maintenance Review Committee.

GUIDE DOGS FOR THE BLIND – Reestablished as a Board effective FY 1998/99.

LANDSCAPE ARCHITECTS – The five members shown under *No. Board Members* are committee members who report to the Board of Architectural Examiners.

NURSING HOME ADMINISTRATORS – The Board sunsetted effective July 1, 1998. The authority and regulation of the nursing home administrators continues under the auspices of the Nursing Home Administrator Program. Sunset language provided the Department with authority over the program; however, an interagency agreement was entered into with the Department of Health Services (DHS) delegating oversight of the Program's day-to-day operations to DHS through June 30, 2001.

VETERINARY MEDICAL AND VETERINARY TECHNICIANS – Registered Veterinary Technicians merged with the Veterinary Medical Board effective FY 1998/99.

VOCATIONAL NURSING AND PSYCHIATRIC TECHNICIANS – One *Field Office* used as an exam site.

Licenses & Registrations

ACCOUNTANCY – Due to the nature of the Board's exams, data for *Written Pass Rate %* cannot be displayed in this table's format. The CPA exam has four sections, not all of which must be taken at one time. A total of 16,721 individuals were scheduled to take some portion of the exam, and 14,092 actually sat for it. For the two exams given in FY 1998/99, between 35% and 41% of the candidates passed each of the four exam sections administered.

ARCHITECTURAL EXAMINERS – *Licenses/ Registrations Renewed* data reflect biennial renewals every odd year. *Examination* data for the last quarter are not yet available from the test vendor. The Board anticipates receipt of the statistics on or after December 1, 1999.

ATHLETIC – *Applications Denied* includes incomplete applications. Effective October 1997, the Commission no longer schedules exams.

AUTOMOTIVE REPAIR AND SMOG CHECK – *Written Pass Rate %* for the Smog Check Technician exam is 76% and 42% for the Brake/Lamp Adjuster exam.

CEMETERY AND FUNERAL – With implementation of new legislation in FY 1997/98, the examination requirement was repealed for Cemetery Salespersons, increasing the number of *Applications Received*. Additional legislation requires Funeral Director Managers to obtain a personal license to remain in the workforce. This would account for the increase in the *Total Active Licenses* reported. In the past, there was no mechanism in place to track the number of Funeral Director Managers in the industry. A new requirement effective July 1, 1999, requires candidates to possess an AA degree or equivalent to qualify to take an examination. The Program conducted an examination in June 1999 that resulted in a 54% increase in *Applications Received* and candidates scheduled for the examination. Data displayed for the *Exams Scheduled* and *Written Pass Rate %* are for the Funeral Program only. The Cemetery Program scheduled 44 written exams, with a 75% *Written Pass Rate*.

ENGINEERS AND LAND SURVEYORS – *Applications Received* reflects only those applications received within the specified 1998/99 fiscal year. Data on actual *Examination* results and *Licenses/ Registrations Issued* are based on October 1998 and April 1999 test administrations only. There is no relationship between the number of *Applications Received* and the actual *Pass Rate %* within the fiscal year.

GUIDE DOGS FOR THE BLIND – Reestablished as a Board effective FY 1998/99.

Licenses & Registrations, Cont.

MIDWIFERY – The decrease in *Licenses/Registrations Issued* in FY 1998/99 is due in part to the fact that the two previous years were the first years that licensure was available to midwives in California. After that initial group of applicants came through the process, activity dropped off, in large part due to the unavailability of approved midwifery programs and the limited capacity of the challenge mechanism. The decrease in *Exams Scheduled* during FY 1998/99 was caused by an exam fee increase imposed by the exam provider, which was in excess of the maximum allowable dollar figure in statute. While amendments to B & P Code Section 2520 to allow for future fee increases were in process, applicants for the licensing exam were referred to another state licensing board to sit for its exam.

NURSING HOME ADMINISTRATORS – Due to the nature of the tracking system, data for *Total Active Licenses/Registrations* and *Total Inactive Licenses/Registrations* cannot be displayed in this format; however, there are currently more than 3,800 licensed administrators in the state. Applicants take a two-part written exam: a state exam and a national exam. Two exams were scheduled during the fiscal year with a *Pass Rate %* of 51% for the state exam and 43% for the national exam.

OPTOMETRY – *Exams Scheduled* increased on a one-time basis due to the switching of the summer examination from July to June; thereby, displaying data for three exams instead of two in this fiscal year.

PHYSICAL THERAPY (PTBC) – *Exams Scheduled* and the *Written Pass Rate %* are based on the National Physical Therapist and Physical Therapist Assistant practice exams only. The PTBC also administered 1,618 Laws and Regulations (Jurisprudence) examinations during FY 1998/99: 1,463 applicants passed, for a *Written Pass Rate* of 90%.

PHYSICIANS ASSISTANT – Includes Supervising Physician approval data: 1,469 *Applications Received*; 1,486 approvals *Issued*; 10,161 *Active*; 4,120 *Inactive*; and 3,871 *Renewed*.

PODIATRIC MEDICINE – Includes limited license data: 69 *Applications Received*; 69 *Licenses/Registrations Issued*; and 120 *Active*. FY 1997/98 *Active* indicated 2,141 incorrectly; it should have been 2,122. FY 1997/98 *Inactive* indicated 100; it should have been 460.

PRIVATE POSTSECONDARY AND VOCATIONAL EDUCATION – The increase in *Applications Received* and *Licenses/Registrations Issued* is a result of additional staff being hired at the Bureau during FY 1998/99, which resulted in additional workload being processed. Due to the nature of the tracking system, applications approved, withdrawn, and abandoned are counted as *Licenses/Registrations Issued*. This is because the Bureau views all of these categories as finalized.

PSYCHOLOGY – Data reflect license and registration activity for Licensed Psychologists, Registered Psychologists, and Registered Psychological Assistants combined. *Applications Denied* is formal denials, withdrawals, unqualified applicants, and deceased applicants. *Exams Scheduled* and *Pass Rate %* data apply to Licensed Psychologists only.

RESEARCH PSYCHOANALYSTS – *Renewed* data reflect a biennial renewal date. License renewal occurs February of every even-numbered year.

SPEECH-LANGUAGE PATHOLOGY AND AUDIOLOGY – FY 1997/98 *Applications Received* displayed 1,377 in error; it should have been reported as 549.

VETERINARY MEDICAL – Total *Exams Scheduled* includes 303 National Board Examinations (NBE); 447 California State Boards (CSB); 287 Clinical Competency Tests (CCT); 41 California Reciprocity Examinations (CRE); 22 Reciprocity Veterinary Licensing Examinations

(RVLE); and 120 Regular Veterinary Licensing Examinations (VLE). *Written Pass Rate %* consists of 60% NBE; 83% CSB; 60% CCT; and 100% CRE, VLE, and RVLE.

VOCATIONAL NURSING AND PSYCHIATRIC TECHNICIANS – *Active* includes 150-day temporary licenses. *Inactive* includes delinquent, inactive, and continuing education holds.

Certificates & Permits

ATHLETIC – *Applications Received*, *Certificates/Permits Issued*, and *Active* are Closed Circuit Telecast permits. In FY 1998/99 there were no major closed circuit boxing events (i.e., Holyfield vs. Tyson).

AUTOMOTIVE REPAIR AND SMOG CHECK – The Gold Shield Program began in May 1997. Data for *Applications Received* and *Certificates/Permits Issued* in FY 1997/98 reflect the initial "rush" from smog stations submitting their applications to be considered for the program. The decrease in *Applications Received* and *Certificates/Permits Issued* in FY 1998/99 is reflective of the average volume of applications.

CEMETERY AND FUNERAL – Data applies to the Funeral Program only.

CONTRACTORS – Data reflect the Board's implementation of a new Home Improvement Certification effective January 1, 1999.

ENGINEERS AND LAND SURVEYORS – *Applications Received* reflects only those applications that were received within the specified 1998/99 fiscal year. Data on actual *Examination* results and *Certificates/Permits Issued* are based on October 1998 and April 1999 test administrations only. There is no relationship between the number of *Applications Received* and the actual *Pass Rate* within the fiscal year.

NURSING HOME ADMINISTRATORS – *Certificates/Permits Issued* are currently licensed nursing home administrators who attend Board-approved preceptor training.

PHYSICIANS ASSISTANT – *Applications Received, Certificates / Permits Issued, and Active* are Physician Assistant Interim Approval permits.

PODIATRIC MEDICINE – Includes Ankle Surgery certificate data: 9 *Applications Received* and 9 *Certificates/Permits Issued*. *Active* and *Renewed* data represent Fictitious Name permits only. Due to the nature of the tracking system, Ankle Surgery certificate data for *Active, Inactive* and *Renewed* are not available.

PRIVATE POSTSECONDARY AND VOCATIONAL EDUCATION – The increase in *Applications Received, Denied, and Certificates/Permits Issued* is a result of additional staff being hired at the Bureau during FY 1998/99, which resulted in additional workload being processed. Due to the nature of the tracking system, applications approved, withdrawn, and abandoned are counted as *Certificates/ Permits Issued*. This is because the Bureau views all of these categories as finalized. *Certificates/ Permits* include Agent Permits that are valid for one calendar year.

REGISTERED NURSING – Effective July 1, 1998, Clinical Nurse Specialist was mandated as a new certification category.

RESPIRATORY CARE – *Applications Received* data are included with the License/ Registration applications on the previous chart.

SECURITY AND INVESTIGATIVE SERVICES –

FY 1997/98 *Applications Received* data were applications sent out to the training facilities for issuance of baton permits. DCA does not actually issue the permits. What we are issuing is the application to the training facilities, which may or may not be completed. Therefore, baton permit applications were not counted in the data reported for FY 1998/99. The increase the *Total Inactive Certificates/Permits* for FY 1998/99 is due to Firearm Qualifications (FQ) permit holders not renewing because of a change in the law which requires four (4) requalifications. The increase in *Renewal* data for FY 1998/99 is the result of a change to a 2-year FQ renewal cycle. The FY 1997/98 *Exams Scheduled* data reflected a monthly exam. In FY 1998/99, the examination was decreased to only six times yearly.

VOCATIONAL NURSING – *Certificates/Permits Issued* includes 10 Interim permits, 1,701 Intravenous Therapy certificates, 466 Blood Withdrawal certificates, and 561 Intravenous Therapy/Blood Withdrawal certificates. These data reflect a decrease due to a new requirement that Department of Justice fingerprint clearance be received prior to issuance of an Interim permit.

Fingerprints

ATHLETIC – *Fingerprints* are required for original promoter, matchmaker, and manager applicants.

CEMETERY AND FUNERAL – *Fingerprints* are required for the Funeral Program only.

GUIDE DOGS FOR THE BLIND – Reestablished as a Board effective FY 1998/99.

NURSING HOME ADMINISTRATORS – Data are unavailable for *Fingerprints* because of Program sunset, transition, and office relocation.

PHYSICIANS ASSISTANT – *Fingerprints* applies to Physician Assistant licenses only.

PSYCHOLOGY – Data reflect *Fingerprint* activity for Licensed Psychologists, Registered Psychologists, and Registered Psychological Assistants combined.

SECURITY AND INVESTIGATIVE SERVICES – FY 1998/99 *Fingerprints* increased due to a decrease in the Department of Justice's (DOJ) turnaround time for clearances and rap sheets to 1 to 3 months. In FY 1997/98, the turnaround time on clearances and rap sheets from DOJ was 3 to 6 months.

STRUCTURAL PEST CONTROL – *Fingerprints* are only requested of applicants indicating a prior conviction(s) on their application.

VOCATIONAL NURSING AND PSYCHIATRIC TECHNICIANS – *Fingerprints* includes 387 rap sheets and 159 subsequent arrest reports for Vocational Nursing, and 59 rap sheets and 13 subsequent arrest reports for Psychiatric Technicians.

ENDNOTES

Approvals/Accreditation and Continuing Education

ACCOUNTANCY – The Board does not approve *Continuing Education Providers* generally. This figure displays only the number of providers approved for the Professional Conduct and Ethics requirement and does not include the many providers offering other continuing education courses.

PRIVATE POSTSECONDARY AND VOCATIONAL EDUCATION – *Approvals/Accreditation* represents data available for approved degree granting and non-degree granting institutions as of June 30, 1999.

PSYCHOLOGY – *Number of Providers* and *Number of Audits* are applicable to Licensed Psychologists only.

SPEECH-LANGUAGE PATHOLOGY AND AUDIOLOGY – Data on this chart reflect implementation of a Continuing Professional Development Program mandated by AB 205 that became effective January 1, 1999. Emergency regulations were adopted by the Secretary of State on April 7, 1999.

STRUCTURAL PEST CONTROL – In previous years, the Board did not report the *Number of Continuing Education Audits* due to the lack of tracking capability. All licensees are required to have a minimum number of continuing education hours based on the type of license being renewed. This report reflects the actual number of renewal applications that were audited for continuing education hours.

VETERINARY TECHNICIANS – *Number of Approvals* is from quarterly reports submitted pursuant to CCR 2065.9.

Complaints Received

ATHLETIC – *Public* is telephone and email complaints regarding unlicensed mixed martial arts events and martial arts schools. *Internal/Other* is boxer/manager contract disputes.

AUTOMOTIVE REPAIR AND SMOG CHECK – The increase in the *Internal/Other* category of complaints over FY 1997/98 is due to a redirection of the Unlicensed Activity Unit's entire workload toward the Automotive Repair Program.

GUIDE DOGS FOR THE BLIND – Reestablished as a Board effective FY 1998/99.

PRIVATE POSTSECONDARY AND VOCATIONAL EDUCATION – Complaint source data are not available, although it is probable that the *Total Complaints Received* derived from more than one source.

SECURITY AND INVESTIGATIVE SERVICES – The decrease compared to FY 1997/98 data reported for *Government/Law Enforcement* is due to the reduction of cases referred to the program from external agencies/sources and the Division of Investigation. The increase in *Internal/Other* over data reported for FY 1997/98 is due to the redirection of the Unlicensed Activity Unit's workload entirely toward the Automotive Repair Program.

VETERINARY TECHNICIANS – In previous years, cases against Registered Veterinary Technicians (RVT) were opened under the managing licensee rather than the RVT; therefore, data were included in the Veterinary Medicine display. Education of licensees is a direct result of the increase shown in enforcement activity.

Complaints Closed Without Going to Investigation

AUTOMOTIVE REPAIR AND SMOG CHECK – The increase in the *Unlicensed/Unregistered* category of complaints over FY 1997/98 is due to a redirection of the Unlicensed Activity Unit's entire workload toward the Automotive Repair Program.

CEMETERY AND FUNERAL – *Total Complaints Closed* decreased due to the transition of complaint mediation functions and enforcement functions from centralized DCA management to the Cemetery and Funeral Program.

GUIDE DOGS FOR THE BLIND – Reestablished as a Board effective FY 1998/99.

NURSING HOME ADMINISTRATORS – Data are unavailable because of Program sunset, transition, and office relocation.

PHARMACY – These data represent complaints that were mediated rather than referred for formal investigation.

PHYSICIANS/SURGEONS – *Discipline by Another State or Agency* increased from last fiscal year due to a shift in responsibility from non-sworn investigators to complaint analysts.

PRIVATE POSTSECONDARY AND VOCATIONAL EDUCATION – Category data for *Complaints Closed* are not available, although it is probable that the number of complaints closed are from multiple categories.

SECURITY AND INVESTIGATIVE SERVICES – The decrease compared to FY 1997/98 data reported for *Unlicensed/Unregistered* is due to the reduction of cases referred to the program from external agencies/sources and the Division of Investigation.

VETERINARY TECHNICIANS – In previous years, cases against Veterinary Technicians (RVT) were opened under the managing licensee rather than the RVT; therefore, data were included in the Veterinary Medicine display. Education of licensees is a direct result of the increase shown in enforcement activity.

Informal Actions

AUTOMOTIVE REPAIR AND SMOG CHECK – *Warning / Cease and Desist Letters Issued* includes first warning, and cease and desist letters issued by the Unlicensed Activity Unit. The increase over data reported for FY 1997/98 is due to a redirection of the Unlicensed Activity Unit's entire workload toward the Automotive Repair Program. *Office Conference* data may include Educational Conference statistics.

GUIDE DOGS FOR THE BLIND – Reestablished as a Board effective FY 1998/99.

PHYSICIANS/SURGEONS – The decrease from FY 1997/98 data reflects the utilization of the Board's Cite and Fine program instead of cease and desist letters.

PRIVATE POSTSECONDARY AND VOCATIONAL EDUCATION – The increase in "Informal Actions" is a result of additional staff being hired at the Bureau during FY 1998/99, which resulted in additional workload being processed.

REGISTERED NURSING – Alternative methods are now in use in lieu of *Warning/Cease and Desist Letters Issued*.

SECURITY AND INVESTIGATIVE SERVICES – *Warning/Cease and Desist Letters Issued* has decreased significantly due to budget expenditure overrun. *Informal Hearings* data are Disciplinary Review Committee hearings only.

STRUCTURAL PEST CONTROL – In previous years, *Warning/Cease and Desist Letters Issued* data were manually gathered for this report. It is apparent that the information gathered was not consistently reported from year to year. Therefore, these data are not reflected in this report. The Board will begin reporting these data once a tracking system can be implemented.

VOCATIONAL NURSING AND PSYCHIATRIC TECHNICIANS – *Office Conference/Informal Hearings* include 108 probation compliance and 3 remediation meetings for Vocational Nursing, and 37 probation compliance meetings for Psychiatric Technicians.

Complaints Referred to Sworn Investigators for Investigation

ACCOUNTANCY – *Investigations Closed, Pending, and Referred to AG* are combined under "Complaints Referred to Non-Sworn Investigators for Formal Investigation."

BARBERING AND COSMETOLOGY – *Investigations Pending* include investigations pending completion by the Division of Investigation or pending closure or further action by program staff.

COURT REPORTERS – *Investigations Opened* include cases sent directly to the District Attorney General's office for disciplinary action.

GUIDE DOGS FOR THE BLIND – Reestablished as a Board effective FY 1998/99.

NURSING HOME ADMINISTRATORS – Data are unavailable because of Program sunset, transition, and office relocation.

PRIVATE POSTSECONDARY AND VOCATIONAL EDUCATION – Category data for *Investigations Closed* are not available, although it is probable that the number of investigations closed is from multiple categories.

REGISTERED NURSING – The tracking system does not permit data separation of sworn and non-sworn investigators for investigations.

SECURITY AND INVESTIGATIVE SERVICES – The number of "Complaints Referred to Sworn Investigators for Investigation" has decreased as compared to data reported for FY 1997/98 due to budget restrictions and the referral of more cases to the program's field staff. Due to the nature of the tracking system, data for *Investigations Closed* cannot be displayed by category.

VETERINARY TECHNICIANS – In previous years, cases against Registered Veterinary Technicians (RVT) were opened under the managing licensee rather than the RVT; therefore, data were included in the Veterinary Medicine display. Education of licensees is a direct result of the increase shown in enforcement activity.

Complaints Referred to Non-Sworn Investigators for Investigation

ACCOUNTANCY – *Total Investigations Closed* includes 45 complaints referred to sworn investigators for formal investigation. *Referred to AG* includes complaints referred to both sworn and non-sworn investigators.

AUTOMOTIVE REPAIR AND SMOG CHECK – Individual investigations reported may include multiple licensees. Changes in the data reported for *Fraud vs. Incompetence/ Negligence* as compared to FY 1997/98 is due to an improved in-house tracking program that allows for more accurate tracking of the administrative outcomes for each investigation closed. The increase in *Unlicensed/ Unregistered* activity over data reported for FY 1997/98 is a result of backfilling full-time Unlicensed Activity field staff positions, which allowed the unit to investigate more cases for the Automotive Repair Program.

Complaints Referred to Non-Sworn Investigators for Investigation, Cont.

ENGINEERS AND LAND SURVEYORS – *Investigations Opened* includes 14 complaints submitted to the Division of Investigation (DOI) for assistance. *Investigations Closed* includes 11 complaints closed by the Board that DOI returned for further action after completing its portion of the investigation. *Pending* includes 12 pending at DOI. *Referred to DA/CA* data are DOI referrals to the District Attorney for criminal prosecution.

GUIDE DOGS FOR THE BLIND – Reestablished as a Board effective FY 1998/99.

PHYSICIANS/SURGEONS – *Discipline By Another State or Agency* decreased due to a shift in responsibility from non-sworn investigators to complaint analysts.

SECURITY AND INVESTIGATIVE SERVICES – The decrease in *Investigations Referred to the Attorney General (AG)* and to the *District Attorney's Office (DA/CA)* as compared to data reported in FY 1997/98 is due to budget restrictions within the program.

Actions Filed

AUTOMOTIVE REPAIR AND SMOG CHECK – *Actions Filed* is individual actions taken against each licensee affected by an investigation. The increase in *Citations Issued* over data reported for FY 1997/98 is due to the implementation of covert audits against Test Only and Gold Shield Stations. The increase in *Civil Actions* over data reported for FY 1997/98 is the result of several cases against major automotive repair chains.

DENTAL EXAMINERS – *Criminal Actions* includes those filed in civil courts.

GUIDE DOGS FOR THE BLIND – Reestablished as a Board effective FY 1998/99.

PHYSICIANS/SURGEONS – *Interim Suspension Orders* include 31 interim orders; 2 temporary restraining orders; 8 automatic suspension orders pursuant to Business and Professions (B&P) Code 2236.1; 12 out-of-state suspension orders pursuant to B&P Code 2310; 4 license restrictions pursuant to Section 23 of the Penal Code; and 5 stipulated agreements to suspend or restrict the practice of medicine.

STRUCTURAL PEST CONTROL – Most *Accusations* contain multiple licensees. *Citations Issued* data reflect implementation of the Board's second Cite and Fine program on January 1, 1999. In prior years, the Board reported Pesticide Use citations from its first program. Pesticide Use citations are now tracked by the Department of Pesticide Regulation and are no longer reflected in this report. However, it should be noted that the Pesticide Use citations are issued to structural pest control licensees.

VETERINARY TECHNICIANS – In previous years, cases against Registered Veterinary Technicians (RVT) were opened under the managing licensee rather than the RVT; therefore, data were included in the Veterinary Medicine display. Education of licensees is a direct result of the increase shown in enforcement activity.

Administrative Outcomes

ATHLETIC – *Revocation* is professional boxers retired for inability to compete. *Suspension Only* is medical suspensions for boxers knocked out, injured, etc.

GUIDE DOGS FOR THE BLIND – Reestablished as a Board effective FY 1998/99.

NURSING HOME ADMINISTRATORS – Data are unavailable because of Program sunset, transition, and office relocation.

SECURITY AND INVESTIGATIVE SERVICES – The increase in *Revocation* as compared to data reported in FY 1997/98 is due to an elimination of backlogged cases at the Disciplinary Review Committee.

Petitions for Penalty Relief

PRIVATE POSTSECONDARY AND VOCATIONAL EDUCATION – "Petitions for Penalty Relief" data does not include conditional approvals.

Inspection Data

ATHLETIC – *Number of Inspections* includes amateur and professional boxing and martial arts events, boxing gyms, mixed martial arts, and submission fighting events. *Notices of Violation Issued* includes unlicensed mixed martial arts events.

AUTOMOTIVE REPAIR AND SMOG CHECK – *Number of Inspections* includes both initial and periodic inspections of automotive repair dealers, smog check stations, and lamp and brake stations. Also included are quality assurance inspections and inspections relating to the Low Income Repair Assistance and Vehicle Repair Programs.

BARBERING AND COSMETOLOGY – *Compliance Verified* includes compliance received for citations issued to establishments and to individuals cited within the establishment. The citation may not have been issued during FY 1998/99; however, the compliance was received during FY 1998/99. *Inspection Citations Issued* includes citations issued to establishments and to the individuals within the establishment during FY 1998/99.

GUIDE DOGS FOR THE BLIND – The Board inspects each school licensee at least once a year.

NURSING HOME ADMINISTRATORS – Data are unavailable because of Program sunset, transition, and office relocation.

PHARMACY – *Total Number Inspections* has decreased dramatically. The board has experienced a 55% vacancy rate in inspector positions due to a salary inequity with pharmacists practicing in the private sector. Additionally, to enhance compliance with pharmacists' law, the board implemented a pharmacy self-assessment program this past fiscal year. Pharmacists are now required to complete a self-assessment on a biennial basis confirming their compliance with pharmacists' law.

PRIVATE POSTSECONDARY AND VOCATIONAL EDUCATION – Number of inspections reported in FY 1997/98 was incorrect. No inspections were identified at that time.

STRUCTURAL PEST CONTROL – "Inspection Data" reflect implementation of the Board's Cite and Fine program on January 1, 1999.

Drug Diversion Programs

PODIATRIC MEDICINE – Effective January 1, 1999, the Board's Drug Diversion Program was sunsetted (SB 1981).

Monetary Savings/Cost Recovery

CEMETERY AND FUNERAL – *Total Cost Recoveries Ordered to the Board* is monies received through court order. *Total Restitution Ordered to Consumers* is monies returned to trust funds per court order.

PHYSICIANS ASSISTANT – *Cost Recoveries Ordered to the Board* is based on final disciplinary and citation decisions that became effective during FY 1998/99.

PRIVATE POSTSECONDARY AND VOCATIONAL EDUCATION – *Refunded to Consumers* is monies refunded through complaint mediation. This was stated in the FY 1997/98 report as "refunded through the Student Tuition Recovery Fund," but the figure reported for FY 1997/98 actually represented monies refunded through complaint mediation.

STRUCTURAL PEST CONTROL – The Board does not currently have a tracking system to collect data for *Total Cost Recovery Ordered to Board*; therefore, data reported for FY 1998/99 may not be fully represented.

GLOSSARY OF TERMS

Accusation – A formal, written statement of charges.

B&P Code – The Business and Professions Code, which contains the statutes governing the Department of Consumer Affairs and its licensing boards.

B&P Code Section 480-485 – A statute whereby applications are denied.

B&P Code Section 800 – A statute requiring specified healing arts boards to create and maintain a central file containing an historical record of licensees.

Certificate/Permit – A document issued to an individual who also holds a valid license or registration that requires a secondary permit or certificate for specialized work.

Citation – A written formal order to pay a fine and/or correct a condition.

Civil Action – A court proceeding initiated by a person or other entity to enforce private rights or obtain redress.

Complaint – A communication alleging a violation of the Practice Act.

Continuing Education – Additional education required by a board for licensure renewal.

Contractual (violation) – Failure to provide or comply with terms of a contract/invoice or to honor a warranty.

Conviction of a Crime – Conviction of a crime related to the practice or profession. (Design/Construction Agencies only)

Cost Recovery – An order directing a licensee to pay the costs of investigating and prosecuting an administrative disciplinary action against the licensee.

Criminal Action – The proceeding by which a party charged with a crime is accused and brought to trial.

Criminal Charges/Convictions – Misdemeanor or felony charges of conviction reported to the boards/ commission, regardless of the nature of the crime (i.e., criminal conviction for embezzlement is categorized under this category, not “fraud.”) (Healing Arts Agencies only)

Drug-Related Offenses – Violations involving controlled substances or dangerous drugs in which self-use has not been established. For example, illegally obtaining, diverting, or possessing drugs; falsifying records pertaining to drugs, illegal sales of drugs, or illegal/inappropriate prescribing or dispensing. (Healing Arts Agencies only)

Formal Investigations by Non-Sworn Investigators – Complaints referred to a non-sworn board investigator, inspector, or consultant to determine if violation of law has occurred.

Formal Investigations by Sworn Investigators – Complaints referred to the Division of Investigation or a sworn board investigator to determine if violations of law have occurred.

Fraud – Intentional acts of misrepresentation, supplying false information in connection with license application or renewal, illegal advertising, misleading advertising, substitution of goods/ services, fraudulent billing (including Medi-Cal and insurance fraud), or unfair business practices (B&P Code 17200).

Health & Safety – Improper use of a toxic or hazardous substance, prescription abuses, sanitation deficiencies, and sale of dangerous substances or products.

Incompetence/Negligence – Substandard workmanship, departure from professional standards of practice, inadequate skills, or lack of knowledge. (Design/Construction and Business Services Agencies only. See Negligence/Incompetence for Healing Arts Agencies)

Informal Action – Notification informing a licensee that he or she is in violation of the statutes or regulations of a board/committee. The notification is accomplished by a letter of reprimand, notice of warning, violation letter, office conference, informal hearing, education letter, or cease-and-desist letter.

Inspection – Inspection of a licensed business resulting from a consumer complaint or for any other enforcement purpose.

Interim Suspension Order – A temporary order of an Administrative Law Judge that immediately suspends a license pending the outcome of disciplinary action taken by the board.

Monetary Savings – A refund to the consumer through mediation efforts (between a consumer and a licensee) of actual money, services performed without charge, changes made in dollar amounts owed by the consumer, or return and exchange of product purchased.

Negligence/Incompetence – Quality of care issues, departure from professional standards of practice, inadequate skills, lack of knowledge, excessive treatment, inadequate or inappropriate supervision, reports of malpractice, or hospital disciplinary reports. (B&P Code 800, Healing Arts Agencies only)

Non-Jurisdictional – Issues not specifically covered by statute (fee disputes, discourtesy, referrals to other agencies, etc.).

Notice of Violation – A notice to a licensee documenting the licensee's failure to comply with a statute or regulation.

Personal Conduct – Drug/alcohol abuse, moral turpitude, mental illness, or conviction of a crime (regardless of the nature of the crime).

Petition for Modification/Termination of Probation – A request by a licensee who is on probation as a result of a disciplinary action to change or delete specified terms of the probation or to end the probation prior to its designated completion date.

Petition for Reinstatement – A request by a licensee whose license has been revoked to have the license reinstated.

Petition to Compel Examination – A formal order by the board requiring a licensee to take a psychological, physical, or competency exam. Failure to comply with said order may result in additional action by the board.

Petition to Revoke Probation – A request filed by the board/committee to terminate probation resulting from a licensee's failure to comply with some or all terms of probation.

Probation – A license placed on probation as a result of a disciplinary action with specified terms and conditions attached. (Also included is suspension stayed, probation only; revocation stayed, probation only; revocation stayed, condition and probation; and initial licenses and reinstatements issued on probation.)

Probation with Suspension – A license placed on probation with a specified suspension period resulting from a disciplinary action. (Also included is revocation stayed, suspension and probation;

suspension stayed, suspension and probation; revocation stayed, suspension, condition and probation.)

Product/Service Quality – Defective goods or products not performing as warranted, or dissatisfaction with services rendered.

Professional Misconduct – Unlawful business practices, abandonment, failure to release/return records, or aiding and abetting unlicensed activity. (Design/Construction Agencies only)

Public Reprimand – A reproof of a licensee that is a matter of public record for conduct in violation of the law. (Also included are public letters of reprimand pursuant to B&P Code Section 2233.)

Referred to AG – When an investigation of a complaint regarding the conduct of a licensee reveals violation of the Business and Professions Code, the results are submitted to the State Attorney General (AG) for administrative purposes.

Referred to DA/CA – When an investigation of a complaint regarding the conduct of a licensee reveals violation of the Business and Professions Code, the results are turned over the local district attorney (DA) or a city attorney (CA) for legal action.

Restitution – A court order directing a licensee to pay the consumer money resulting from a disciplinary action against the licensee.

Restraining Order – An order from a court to refrain from engaging in particular unlawful conduct.

Revocation – The invalidation of an individual's license to practice a profession as a result of an administrative or disciplinary action.

School Approval/Accreditation – Certification that a school meets the required criteria for licensure.

Sexual Misconduct – Any act of sexual misconduct, including sexual abuse, sexual contact or relations with a client, sexual harassment, etc. (Healing Arts and Business Services Agencies only)

Statement of Issues – A formal written statement of charges denying an application for a license.

Substance Abuse or Mental/Physical Impairment – Drug or alcohol abuse or impairment because of mental or physical illness. (Healing Arts Agencies only)

Surrender of License – The voluntary surrender of a license by the licensee resulting from a disciplinary action.

Suspension – A decision resulting from a disciplinary action whereby the right to practice a profession is temporarily discontinued or withdrawn. (Also included is revocation stayed, suspension only.)

Unlicensed/Unregistered – Unlicensed/unregistered activity, or aiding and abetting unlicensed activity.

Unprofessional Conduct – Unlawful business practices, abandonment, failure to release/return records, or breach of confidentiality. (Business Services Agencies only)

Unprofessional Conduct – Patient/client abandonment, failure to release return records, breach of confidentiality, unethical practices, acts of violence, theft, failure to report abuse (child, spousal, elder, or dependent adult), or dual relationships. (These complaints do not include criminal convictions/charges and relate only to Healing Arts Agencies.)
